ADDITIONAL BOARD COMMENTS

Mrs. Spade stated that although she inadvertently approved all Personnel Items, she did not want to approve the Goal Bonuses for Act 93 Employees. She does not believe in bonuses and especially when we are approving an increase in the tax rate. She also stated that she understands this is a component of an employment contract, but she disagrees with it and was not on the Board when this contract was approved.

Mr. Wielgus stated that these bonuses are a component of the current Act 93 Contract, and this district does not breach contracts with any of its unions or employee groups. He also spoke in support of our administrative team stating that we have asked them to absorb more work over the past few years, and they are deserving of the bonuses.

Dr. Mannarino explained that these are not arbitrary bonuses awarded just because the district had extra money or that we thought the administrators did a good job. Administrator goals are set at the beginning of the year, reviewed by the Board, and are task and projects that are not necessarily a part of the expectations of their job descriptions. Our administrators have done outstanding work on these additional goals and several of them have been asked to present regionally and nationally regarding specific projects. Dr. Mannarino state this system has been in place for many years, and he fully supports it.

Mr. Wielgus adjourned the meeting at 7:43 p.m.
